Notice of Religious Freedom Regarding Vaccine Mandates and Passports

Notice to Agent is Notice to Principal and Notice to Principal is Notice to Agent

I, ______, one of the People (as seen in the Arizona State Declaration of Rights) am giving you this notice that you and your agents may provide due care and carefully act to cease and desist from all interference with the rights of the People;

The Arizona Constitution Preamble states: "We the people of the State of Arizona, grateful to Almighty God for our liberties, do ordain this Constitution."

Please Take Notice: From the inception of the State of Arizona, Almighty God was acknowledged. In addition, from the inception of US Constitution, Amendment I, religious freedom was guaranteed.

Please Take Further Notice: The People's right to practice religion, in its various forms, was established from that point to the present.

Arizona Constitution Declaration of Rights Article 2 Section 2- Political Power; Purpose of Government Section 2. "All political power is inherent in the people, and governments derive their just powers from the consent of the governed, and are established to protect and maintain individual right." [Emphasis by highlight]

Please Take Notice: In relation to the rights of one of the People of the State of Arizona, or any other of the 50 states, **inalienable** means rights which are not capable of being surrendered or transferred without the consent of the one possessing such rights. Black's Law 5th Ed.

Please Take Further Notice: Within the Arizona State Constitution, there are no provisions for removal of this very first noted basic right of "We, the People."

Arizona State Constitution Article 2 Section 6 - Freedom of Speech and Press

"Every person may freely speak, write, or publish on all subjects, being responsible for the abuse of that right." [Emphasis by highlight]

Arizona State Constitution Article 2 Section 33 - Reservation of Rights

"The enumeration in this Constitution of certain rights shall not be construed to deny others retained by the people" [Emphasis by highlight]

Arizona State Constitution Article 2 Section 5 - Right of Petition and of Assembly

"The **right of petition**, and of the people peaceably **to assemble for the common good**, shall never be abridged." [Emphasis by highlight]

Arizona State Constitution Article 2 Section 4 - Due Process of Law

"No person shall be deprived of life, liberty, or property without due process of law." [Emphasis by highlight]

Take Notice: No state of federal "mandate," may ever violate the inalienable rights of one of We, the People, enumerated in the Arizona Constitution. Concerning my choice, giving informed consent for a vaccination or not to choosing to be vaccinated, no other entity, outside of myself, may make that choice for me.

Take Further Notice: Definition

Unlawful Discrimination: Unlawful discrimination refers to unfair or unequal treatment of an individual or group based on protected status, such as race, color, gender, gender identity, sex, sexual orientation, sexual orientation, religion, national origin, ethnicity, disability, status as a veteran, marital status, pregnancy status, age or other protected group status as defined by law."

Please Take Notice: In compliance with constitutional authority, you as **corporations** in this state must follow the US and Arizona Constitutions and accept the exercise of Religious Freedom without discrimination. This includes my right to choose not to be vaccinated or carry a vaccine passport.

Arizona Constitution Article 14, Section 1– "Corporation" defined; right to sue and suability". Section 1: The term "corporation" as used in this article, shall be construed to include all associations and joint stock companies having any powers or privileges of corporations not possessed by individuals or co-partnerships, and all corporations shall have the right to sue and be subject to be sued, in all courts, in like cases as natural persons".

Arizona Constitution Article 14, Section 13 – Want of legal organization as a defense: "No persons acting as a corporation under the laws of Arizona shall be permitted to set up or rely upon, the want of legal organization as a defense to any action which may be brought against them as a corporation."

Arizona Constitution Article 18 Section 3 –Contractual Immunity of Employer from Liability for Negligence

"It shall be unlawful for any person, company, association, or corporation to require of its servants or employees as a condition of their employment, or otherwise, any contract or agreement whereby such person, company, association, or corporation shall be released or discharged from liability or responsibility on account of personal injuries which may be received by such servants or employees while in the service or employment of such person, company, association, or corporation, by reason of the negligence of such person, company, association, corporation, or the agents or employees thereof; and any such contract or agreement if made, shall be null and void."

Arizona Constitution Article 2 Section 36 – Preferential Treatment or Discrimination Prohibited; Exceptions; Definition

"This state shall not discriminate against or grant preferential treatment to any individual or group on the basis of race, sex, color, ethnicity or national origin in the operation of public employment, public education or public contracting." [Emphasis by highlight]

Arizona Constitution Article 2 Section 12 – Liberty of Conscience: Appropriations for Religious Purposes Prohibited; Religious Freedom

"The liberty of conscience secured by the provisions of this constitution shall not be so construed as to excuse acts of licentiousness, or justify practices inconsistent with the peace and safety of the state. No public money or property shall be appropriated for or applied to any religious worship, exercise or instruction, or to the support of any religious establishment. No religious qualification shall be required for any public office or employment, nor shall any person be incompetent as a witness or juror in consequence of his opinion on matters of religion, nor be questioned touching his religious belief in any court of justice to affect the weight of his testimony." [Emphasis by highlight]

Please note that licentious behavior must not occur on the part of any person, agent or trust indentured servant. Therefore, avoiding licentious behavior would apply to any person, as an agent of the State of Arizona, who attempts to inflict an unlawful mandate on one of the People of the State of Arizona. Licentious behavior may be construed to mean acting without regard to law, ethics, or the rights of others.

Arizona Constitution Article 2 Section 13 – Equal Privileges and Immunities

Section 13. "No law shall be enacted granting **to any citizen**, **class of citizens**, or **corporation** other than municipal, **privileges or immunities** which, upon the same terms, shall not equally belong to all citizens or corporations." [Emphasis by highlight]

Arizona Constitution Article 2 Section 32 - Constitutional Provisions Mandatory

Section 32. "The provisions of this Constitution are mandatory, unless by express words they are declared to be otherwise." [Emphasis by highlight]

Please note that the right to exercise of religion is not limited to a certain time or place; but, is not only allowed, but protected, under all situations and circumstances and is to not be limited by any agency, trust indentured, elected official, or any other influence outside that of the individual.

Please note that equal protection of law describes equal rights and privileges of law and therefore makes null and void any attempt to cause harm personally or financially to any one of the People in the state of Arizona. As the unlawful mandate, disallowing basic rights of the People, violates equal protection of laws, it must be immediately withdrawn and removed from any possibility of further harm to "We, the People.

Please further note that the present "mandate" disallowing the People's inalienable and indefeasible rights to choose religious accommodation, based on strong religious convictions, is without merit and forms an illegal precedent for further overreach of governmental agencies in the future. It is an attempt to disenfranchise and diminish the status of "We, the People" to accomplish an arbitrary end of questionable merit. It is licentious in nature, acting without regard to law, ethics, or the rights of others.

I, acting on my Constitutional authority as the progeny of the creators and sustainers of the Constitution of the United States and the Constitution of the State of Arizona, do hereby require immediate relief from all such mandates and restrictions upon my liberty interests and rights as one of "We, the People." No agency, elected trustee, or entity has or will have authority to direct the private decisions of the People.

My desire is to settle this matter in a calm and harmonious atmosphere of mutual respect. However, no further infringement on the People's rights will be tolerated. Please see to it that this matter is resolved properly and expeditiously. If you desire to respond to this notice, your response must be in the form of an affidavit, answering point by point the statements contained herein; and, it must be received no more than 5 days from the receipt of this notice.
