Notice by Affidavit of Demand to Show Clean Hands and Federal Partnerships [Declaration of Membership in Private Association and Private Status]

Notice to Agent is Notice to Principal and Notice to Principal is Notice to Agent

Comes now Affiant, _____, one of the People (as seen in State or Commonwealth Constitution reference, _____) Sui Juris, in this Court of Record, making the following claims, that you and/any or all of your agents may provide due care;

I, the Affiant, declare that the People in all 50 (Fifty) states are entitled to the protections and rights listed in their several Constitutions which all contain similar language protecting the People's rights as evidenced below from the United States Bill of Rights; [Highlight Added for Emphasis]

The Constitution of the United States Bill of Rights-Amendment X

The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people.

References are taken from various states in the following narrative to impress upon you, the serious nature of your offense and Biblical references are included to remind you that the Oath of Office any Legislative, Judicial, or Executive officer takes at any level, binds you to protecting and defending the Constitution. Those of you who do not take an oath are still in violation of Constitutional provisions that protect the people in every state when you ignore those rights.

I, the Affiant, being one of the People, claim a religious conviction/creed, based on Almighty God, who created the People to do his will, to follow His guidance and instructions on how to treat the bodies in which He clothed us. (see Holy Bible, New King James Version):

"The First Book of Moses>Genesis: The History of Creation - Paragraph 1, Verse 27. "So God created man in His own image; in the image of God, He created him; male and female He created them."

[Highlight Added for Emphasis]

I, the Affiant, agree that among the many gifts God bestowed on His creation is a strong immune system and Affiant has personally vowed, to not take mandated vaccinations, or to inhibit my ability to breathe through a mask or any other face covering which, among many other problems caused by these masks, impairs the flow of oxygen needed to maintain mental and physical health. Therefore Affiant demands that Affiant, Affiant spouse, any minors in

Affiant care, Affiant parents or any other close or extended members of Affiant family are not to be forced, coerced, or harassed into taking part in any such endeavor nor are any Critical Race Theory programs, and/or seminars or training, now referred to as Social Emotional Learning, which includes Equity and Transgender Identification to be used to alter our thinking. Any such actions are a violation against Affiant and Affiant family's constitutional rights as evidenced below; (See North Carolina Constitution)

North Carolina State Constitution, Article I Declaration of Rights, Sec.

13. Religious liberty.

All persons have a natural and inalienable right to worship Almighty God according to the dictates of their own consciences, and **no human authority shall, in any case whatever, control or interfere with the rights of conscience.** [Emphasis by Highlight Added]

Please take notice that Affiant finds that the Social Security Act, Cares Act, Flores Agreement, and Highway Safety Act are all federal programs where actors in the state are allowed to benefit **financially** by administrative actions and/or cooperating with government entities. (Please see example of Social Security Act detailed below): [Highlight Added for Emphasis]

Preamble 1935 Social Security Act: The Social Security Act (Act of August 14, 1935) [H.R. 7260]

An act to provide for the general welfare by establishing a system of Federal old-age benefits, and by enabling the several States to make more adequate provision for aged persons, blind persons, dependent and crippled children, maternal and child welfare, public health, and the administration of their unemployment compensation laws; to establish a Social Security Board; **to raise revenue;** and for other purposes.

Please take further notice; Affiant and Affiant family are in **the Private realm**, and are no longer subject to any governance of statutes, provisions, policies, mandates or any other type of program where Affiant and/or Affiant family would be required to participate in any government or business programs requiring vaccinations, and face masks before being allowed to enjoy their rights which include public education, conducting business, gainful employment, publishing, web publishing, video posting and being out in public including many other personal endeavors enjoyed by the People. [Highlight Added for Emphasis]

The Private Membership Association **(PMA)** has contracted together with Affiant, Affiant family and others. The People hold dominion over government through our Constitution(s) and no government body, corporation, or other entity or agent or person, has been granted authority over the Peoples' private health determinations; [Highlight Added for Emphasis]

New Jersey Constitution Article I Paragraph 18

The people have the right **freely to assemble** together, **to consult** for the common good, to make known their opinions to their representatives and to petition for redress of grievances.

[Highlight Added for Emphasis]

Please take further notice; Affiant contract with the PMA shares a religious conviction that the People were all created in God's image. The PMA is set apart in the Private with inalienable rights. One of which is to protect His temple. Therefore you **are prohibited** from legislating any statutes, or from releasing any executive orders, municipal policies or mandates of any kind against our rights. You are also prohibited from using any commercial or other related

regulation or power; or making claims of working for the advancement of the public health by mandating business practices requiring vaccinations, masks or any other CDC recommendations as a requirement for attending classes in any institution of learning, continued employment, commercial travel on airlines, trains, buses, subways, navy vessels or any other means of commercial transport used by the People. Discriminating against personal medical history is a violation of the Peoples' Constitutional rights. (See California Constitutional reference)
[Highlight Added for Emphasis]

California Constitution Article I Section 8

A person may not be disqualified from entering or pursuing a business, profession, vocation, or employment because of sex, race, **creed, color, or national or ethnic origin. [Emphasis by Highlight Added]** ('creed' comes from the Latin word that means "I believe." It also means faith, religion, even dogma.) **[Highlight Added for Emphasis]**

Affiant claims that the People, having all political power and after hiring servants to carry out their business, never granted authority for those same servants to force the People through programs or provisional systems that are falsely presented as law, to perform or participate in any act to which they are diametrically opposed. (See reference to Arizona Constitution and Blacks Law definitions detailed below):

Arizona Constitution Article II Section 2: Political Power; Purpose of Government "All political power is inherent in the people, and governments **derive their just powers from the consent of the governed; and are established to protect and maintain individual rights."**
[Highlight Added for Emphasis]

Black's Law 4th edition definition for Persons (page 34)

PERSONS are divided by Law into natural and artificial. . ."corporations" or "bodies politic." Quasi municipal corporations--Bodies politic and corporate, created for the sole purpose of performing one or more municipal functions.

Black's Law 4th edition definition for Persons (page 34)

PEOPLE are supreme, not the state. [Waring vs. Mayor of Savannah]; The state cannot diminish the rights of the people. **[Herpado v. California];** . . .at the Revolution, the sovereignty devolved on the people; and they are truly the sovereigns of the country, but they are sovereigns without subjects . . . with none to govern but themselves. **[CHISHOLM v. GEORGIA]:** The people of this State, as the successors of its former sovereign, are **entitled to all the rights which formerly belonged to the King by his prerogative.** **[LANSING v. SMITH]** **[Highlight Added for Emphasis]**

Take further notice that it is hereby Affiant wish, order, and demand for all participating parties to (1) Give full disclosure of any program funds received by any state, municipality, town or political subdivision/public subdivision as part of participating in any state or federal program in **a sworn affidavit**, (2) Cite the original Legislative statutes that granted authority to bring force upon the People in the Private realm **by sworn affidavit**, and (3) Cite the Constitutional authority that gives you the power over the People, in the Private, to force, coerce, and/or harass them into taking any vaccination; to cover their faces with questionable cloth, paper or other materials; to censor all forms of communication; to supply passports for any vaccination as a requirement for use of any public form of transportation; and to mandate performance of any behavior related to government decree of any kind by sworn affidavit; and(4) If you or your agents believe you have Constitutional Authority over the People and/or the CDC has Constitutional authority over the People, please also provide that testimony in the form of a

sworn affidavit, showing that the People have granted this authority that demands they follow one of their own servant's health orders; [Emphasis by Highlight Added]

Affiant demands your response within **five (5) days**. Should you fail to respond to this affidavit by Notice within the time limit of five (5) days, you agree that you are working to attack the People, either against your **Trust Indenture** under the Constitution (s), or as a participant in a government program from which you receive revenue in return for taking these actions. If a **commercial entity**, you agree that you are knowingly **Trespassing** against the rights of the People; if a **legislator**, you agree that you are knowingly **Trespassing** against the rights of the People you swore to protect and are breaking your Oath of Office; or if **in the public sector** and you are **receiving any benefits of any kind** through **cooperation with government** actors, you agree that you are knowingly Trespassing against the rights of the People; and you agree that the CDC has no authority to impose any mandates on the People. [Emphasis by Highlight Added]

Please take further notice that Affiant demands compensation for any action(s) taken against Affiant or Affiant's close or extended family that results in any Harm of any kind caused by your and/or any of your agents denying any of our Constitutional rights. Furthermore, you agree that this affidavit has given you Notice and this Notice by Affidavit can be **used as evidence of your Trespass(es)**; that you agree that you are liable for any harm either physical, mental, emotional or financial that occurs as a result of your actions or those of your employees. In restitution you agree to pay \$250,000 for each encroachment thereof. In addition, you agree that no court shall re-examine this matter; that the courts shall accept the above several agreements listed, regardless of the Trespasser, as truth and law. Affiant agrees to arbitration by an arbitrator of Affiant's choice. [Highlight Added for Emphasis]

42 U.S. Code § 1983. Civil Action for Deprivation of Rights.

Every person who, under color of any statute, ordinance, regulation, custom, or usage, of any State or Territory or other person within the United States or other person within the 8 of 9 jurisdiction thereof to the deprivation of any rights, privileges, or immunities secured by the Constitution and laws, shall be liable to the party injured in an action at law, in equity, or other proper proceeding for redress of grievance. Please take further notice that **the People have the Constitutionally secured Right to bring lawful action**, be it civil or criminal, against any man, woman, corporation, organization or entity, at any time, for unlawful acts committed against them or their person, and for remedy of justice prescribed **for the redress of their grievance**. [Highlight Added for Emphasis]

Please take final notice that the PMA status of Affiant and Affiant family renders your position as indefensible. These actions taken by you, if a legislator, or if a company, its owners, officers and/or other employees, cannot be supported by any Constitutional premise and cannot be legislated or mandated by any governmental body according to our Constitutional rights. (see Virginia Bill of Rights):

Virginia Declaration of Rights

3. That government is, or ought to be, instituted for the common benefit, protection, and security of the people, nation, or community; of all the various modes and forms of government, that is best, which is capable of producing the greatest degree of happiness and safety, and is most effectually secured against the **danger of maladministration; and that whenever any government shall be found **inadequate or contrary to these purposes**, a majority of the community hath an **indubitable, unalienable, and indefeasible right**, to reform, alter, or abolish it, in such manner as shall be judged most conducive to the **public weal**. [Highlight Added for Emphasis]**

Affiant declares that this "Notice by Affidavit", represents your and any/or all of your agents' only warning to cease and desist from enacting, or acting upon, any and all laws, policies, mandates, executive orders, or any other provision that attempts to molest the People or the Peoples' property including their private person(s) or that of their family once they are part of any Private Membership Association.

[Emphasis by Highlight Added]
