**Notice of the People's Right to Freedom of Religion
Notice to Agent is Notice to Principal and Notice to Principal is Notice to Agent**

I, _____, one of the People of the state of New Jersey, as seen in the New Jersey Constitution Article 1 Paragraph I, come to you so you may give due care;

New Jersey Constitution Article 1 Paragraph 1:

“All persons are by nature free and independent, and have certain natural and unalienable rights, among which are those of enjoying and defending life and liberty, of acquiring, possessing, and protecting property, and obtaining safety and happiness.”

I assert that all of the 50 states Constitutions and the United States Constitution assure and guarantee me religious freedom.

United States Constitution Bill of Rights, Amendment I

“Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.”

New Jersey Constitution Article 1 Paragraph 5:

“No person shall be denied the enjoyment of any civil or military right, nor be discriminated against in the exercise of any civil or military right, nor be segregated in the militia or in the public schools, because of religious principles, race, color, ancestry or national origin.”

Please note, I certify that receiving vaccines or other immunizing agents directly conflicts with my religion. **I therefore am asserting my constitutional right of freedom of religion** stated in the Bill of Rights 1st Amendment & the New Jersey Constitution.

New Jersey Constitution Article 1 Paragraph 21:

Maxim of Law - The mandate of an immoral or illegal thing is void. *Dig. 17, 1, 6, 3*.

Please understand that the following quotes, directly from cases, apply to all attempts to trample the God ordained rights of the People.

“An unconstitutional act is not law. It confers no rights; it imposes no duties; affords no protection; it creates no office. It is, in legal contemplation, as inoperative as though it had never been passed.” – Norton v. Shelby County, 118 U.S. 425 (1886)

“Where rights secured by the Constitution are involved, there can be no rule-making or legislation which would abrogate them.” –Miranda v. Arizona, 384 U.S. 436 (1966)

“A law repugnant to the Constitution is void. An act of Congress repugnant to the Constitution cannot become a law. The Constitution supersedes all other laws and the individual’s rights shall be liberally enforced in favor of him, the clearly intended and expressly designated beneficiary.” –Marbury v. Madison, 5 U.S. 137 (1803)
