Notice of Religious Freedom

Notice to Agent is Notice to Principal and Notice to Principal is Notice to Agent

I, _____, one of the people (as seen in Article 1 Section 2 of the Texas Constitution) Sui Juris, in this Court of Record, am serving you with due notice, that you may provide due care:

Please take notice that all political power originates from the people, the government officials, are the servants of the people, and government is and has always been based on the will of the people and that no public officer is to handle the people's business based on his or her own will:

Texas Constitution Article 1 Section 2- *"All political power is inherent in the people, and all free governments are founded on their authority, and instituted for their benefit. The faith of the people of Texas stands pledged to the preservation of a republican form of government, and, subject to this limitation only, they have at all times the inalienable right to alter, reform, or abolish their government in such manner as they may think expedient."*

Please take notice that the people, who have all political power, also have the inherent right to assemble and go to their representatives to have their wrongs corrected.

United States Constitution Amendment I: *"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievance."*

Texas Constitution Article 1 Section 27- *"The citizens shall have the right, in a peaceable manner, to assemble together for their common good; and apply to those invested with the powers of government for redress of grievances or other purposes, by petition, address or remonstrance."*

Please take notice that elected or appointed federal government officials and state officials take an oath to uphold the Constitution of the United States.

Title 5 United States Code § 3331- *"An individual, except the President, elected or appointed to an office of honor or profit in the civil service or uniformed services, shall take the following oath:*

"I, _____, do solemnly swear (or affirm) that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; that I take this obligation freely, without any mental reservation or purpose of evasion; and that I will well and faithfully discharge the duties of the office on which I am about to enter. So help me God." This section does not affect other oaths required by law."

Texas Constitution Article 16 Section 1 (a)- (a) All elected and appointed officers, before they enter upon the duties of their offices, shall take the following Oath or Affirmation-

"I, _____, do solemnly swear (or affirm, that I will faithfully execute the duties of the office of _____ of the State of Texas, and will to the best of my ability preserve, protect, and defend the constitution and laws of the United States and of this State, so help me God."

Please take notice that the people of any state are entitled to the same rights and privileges that are found in every other state, and that the people have even more rights than are even explicitly stated in the constitutions.

United States Constitution Article IV Section 2 Clause 1- *"The Citizens of each State shall be entitled to all Privileges and Immunities of Citizens in the several States"*

United States Constitution Amendment IX- *"The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people."*

Please take notice that the Centers for Disease Control (CDC) is not a branch of government. As a non-governmental agency, the CDC does not have any powers regarding law or policy making or any other authority over the people.

Texas Constitution Article 1 Section 28- *"No power of suspending laws in this State shall be exercised except by the Legislature"*

As a non-governmental agency without the authority granted by the people to rule over them, the CDC cannot be given that authority by the government to carry out actions that the government themselves were not granted the authority by the people to do.

Maxims of Law by a Charles A. Weisman Section 4c- *“What I cannot do by myself, I cannot do by another [i.e., an agent] 4 Coke, 24b: 11 Coke, 87a Jenk. Cent. 237.”*

The United States Constitution is the supreme Law of the Land, not statutes, and all governmental bodies and courts are bound to it.

United States Constitution Article VI Clause 1- *“This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.”*

Please take notice that mandating a vaccine that had the potential to cause death would be a violation of his rights as one of the people.

New Jersey Constitution Article 1 Section 1- *“All persons are by nature free and independent and have certain natural and unalienable rights among which are those of enjoying and defending life and liberty, of acquiring, possessing, and protecting property, and pursuing and obtaining safety and happiness.”*

Please take notice that the people have even more rights other than those explicitly stated in the constitutions.

United States Constitution Amendment IX- *“The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.”*

If the judges, the state, and the police are bound to follow the constitutions, which cannot violate the rights of the people, it is only possible for them to violate rights if he is something other than one of the people.

Please take notice that bills of attainder are forbidden by the constitution.

United States Constitution Article I Section 9 Clause 3- *“No Bill of Attainder or ex post facto Law shall be passed.”*

Texas Constitution Article 1 Section 16- *“No bill of attainder, ex post facto law, retroactive law, or any law impairing the obligation of contracts shall be made.”*

Please take notice that the people have guaranteed constitutional rights to prevent legislative interference.

Constitutional right. *A right guaranteed to the citizens by the Constitution and so guaranteed as to prevent legislative interference therewith. See also Constitutional freedom; Constitutional liberty or freedom; Constitutional protections. Black’s Law 5th Edition*

As previously stated, as one of the people, who are free and independent, I am guaranteed certain unalienable rights including life, liberty, and obtaining safety and happiness. By these criteria alone, the people are exempt from such statutes mandating vaccines.

Please take notice that the people, who have all political power, also have a right to privacy, and cannot ever be deprived of life, liberty, or property without due process of law and oath or affirmation.

Black’s Law 4th Edition- **PRIVACY RIGHT OF.** The right to be let alone, the right of a person to be free from unwarranted publicity. *Holloman v. Life Ins. Co. of Virginia*, 192 S.C. 454, 7 S.E.2d 169, 171, 127 A.L.R. 110. The right of an individual (or corporation) to withhold himself and his property from public scrutiny, if he so chooses. It is said to exist only so far as its assertion is consistent with law or public policy, and in a proper case equity will interfere, if there is no remedy at law, to prevent an injury threatened by invasion of, or infringement upon, this right from motives of curiosity, gain, or malice. *Federal Trade Commission v. American Tobacco Co.*, 44 S. Ct. 336, 264 U.S. 298, 68 L.Ed. 696, 32 A.L.R. 786 [Highlight Added for Emphasis]

United States Constitution Amendment IV- *“The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.”*

Arizona Constitution Article 2 Section 8- *“No person shall be disturbed in his private affairs or his home invaded, without authority of law”*

Please take notice that the people’s children are also one of their liberty interests and they cannot be deprived of them by the government.

Virginia Constitution Article 1 Section 1- *That all men are by nature equally free and independent and have certain inherent rights, of which, when they enter into a state of society, they cannot, by any compact, deprive or divest their posterity; namely, the enjoyment of life and liberty, with the means of acquiring and possessing property, and pursuing and obtaining happiness and safety.*

Based on the rights enumerated in the state constitutions, the arbitrary power over the lives, liberty, property, and even children of the people does not exist, and any such attempts to enforce mandates would be in violation of the law of the land.

Please take notice that the people have the right of conscience and that no one is allowed to compel them or interfere in such a way to force the people to go against it.

Pennsylvania Constitution Article 1 Section 3- *“All men have a natural and indefeasible right to worship Almighty God according to the dictates of their own consciences; no man can of right be compelled to attend, erect or support any place of worship or to maintain any ministry against his consent; no human authority can, in any case whatever, control or interfere with the rights of conscience, and no preference shall ever be given by law to any religious establishments or modes of worship.”*

Please take further notice that no governmental body or agency can ever make laws against the rights of the people.

Texas Constitution Article 1 Section 29- *“To guard against transgressions of the high powers herein delegated, we declare that everything in this “Bill of Rights” is excepted out of the general powers of government, and shall forever remain inviolate, and all laws contrary thereto, or to the following provisions, shall be void.”*

Miranda v. Arizona, 384 U.S. 436 (1966)- *“Where rights secured by the Constitution are involved, there can be no rulemaking or legislation which would abrogate them.”*

Please take notice that the people have all political power and that the Constitution is the supreme Law of the Land, which all governmental bodies, including judges are bound to follow it.

Marbury v. Madison, 5 U.S. (1 Cranch) 137; 2L Ed. 60 (1803)- *“Thus, the particular phraseology of the Constitution of the United States confirms and strengthens the principle, supposed to be essential to all written constitutions, that a law repugnant to the Constitution is void and that courts, as well as other departments, are bound by that instrument.”*

Any legislator that has knowledge of such trespass against the people and allows it to continue is complicit and in violation of their trust indenture and any government officials or individuals (such as the executive branch conspiring with an agency or legislature with a judge) who conspire to deprive the people of their rights secured under the Constitution, can be held accountable under the law.

Title 18 United States Code § 241 *“If two or more persons conspire to injure, oppress, threaten, or intimidate any person in any State, Territory, Commonwealth, Possession, or District in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same ... They shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section ...they shall be fined under this title or imprisoned for any term of years or for life, or both, or may be sentenced to death.”*

By the power of the people and the power of the above constitutional provisions, I therefore demand, require, and order that all members of government and agencies will cease the enforcement of vaccine and mask mandates on the people and their children or the use such mandates to limit the people’s access to participation in a free society. It is also my order and demand that if any judge attempts to rule in favor of unconstitutional mandates that legislature calls for their impeachment.

If you believe you have the authority to impose injections and other medical procedures on the people against their will, in violation of their inherent rights, please respond to this notice within five (5) days point by point by affidavit sworn under penalty of perjury with the constitutional provisions showing where you were granted such authority. Failing to do so means you agree with the above claims.
