# Notice of Religious Freedom Regarding Vaccine Mandates

## Notice to Agent is Notice to Principal and Notice to Principal is Notice to Agent

I, \_\_\_\_\_, one of the People (as seen in the Illinois State Bill of Rights) am giving you this notice that you and your agents may provide due care and carefully act to cease and desist from all interference with the rights of the People;

**The Illinois Constitution Preamble** states: "We, the People of the State of Illinois; grateful to Almighty God for the civil, political and religious liberty which He has permitted us to enjoy and seeking His blessing upon our endeavors—in order to provide for the health, safety and welfare of the people; maintain a representative and orderly government; eliminate poverty and inequality; assure legal, social and economic justice; provide opportunity for the fullest development of the individual; insure domestic tranquility; provide for the common defense; and secure the blessings of freedom and liberty to ourselves and our posterity- do ordain and establish this Constitution for the State of Illinois."

**Please Notice**: From the inception of the State of Illinois, Almighty God was acknowledged. In addition, from the inception of US Constitution, Amendment I, religious freedom was guaranteed;

**Please Further Notice:** The People's right to practice religion, in its various forms, was established from that point to the present;

### Illinois Constitution Article 1 Section 1: Inherent and Inalienable Rights

"All men are by nature free and independent and have certain inherent and inalienable rights among which are life, liberty and the pursuit of happiness. To secure these rights and the protection of property, governments are instituted among men, deriving their just powers from the consent of the governed."

**Please Notice**: In relation to the rights of one of the People of the State of Illinois, or any other of the 50 states, **inalienable** means rights which are not capable of being surrendered or transferred without the consent of the one possessing such rights; Black's Law 5<sup>th</sup> Ed.

**Please Further Notice:** Within the Illinois State Constitution, there are no provisions for removal of this very first noted basic right of "We, the People;"

## Illinois State Constitution Article 1 Section 4 – Freedom of Speech

"All persons may speak, write and publish freely, being responsible for the abuse of that liberty. In trials for libel, both civil and criminal, the truth, when published with good motives and for justifiable ends, shall be a sufficient defense."

## Illinois State Constitution Article 1 Section 24 – Rights Retained

"The enumeration in this Constitution of certain rights shall not be construed to deny or disparage others retained by the individual citizens of the State.

## Illinois State Constitution Article 1 Section 5 – Right to Assemble and Petition

"The people have the right to assemble in a peaceable manner, to consult for the common good, to make known their opinions to their representatives and to apply for redress of grievances."

#### Illinois State Constitution Article 1 Section 2 – Due Process of Law

"No person shall be deprived of life, liberty or property without due process of law nor be denied the equal protection of the laws."

**Please Notice:** No state of federal "mandate," may ever violate the inalienable rights of one of We, the People, enumerated in the Illinois Constitution. Concerning my choice, giving informed consent for a vaccination or not to choose to be vaccinated, no other entity, outside of myself, may make that choice for me or for my children;

## **Take Further Notice: Definition**

Unlawful Discrimination: Unlawful discrimination refers to unfair or unequal treatment of an individual or group based on protected status, such as race, color, gender, gender identity, sex, sexual orientation, sexual orientation, religion, national origin, ethnicity, disability, status as a veteran, marital status, pregnancy status, age or other protected group status as defined by law."

**Please Notice:** In compliance with constitutional authority, you as agencies and/or corporations in this state must follow the US and Illinois Constitutions and accept the exercise of Religious Freedom without discrimination. This includes my right to choose not to be vaccinated or allow my children to be vaccinated;

## Illinois Constitution Article 1 Section 20 – Individual Dignity

"To promote individual dignity, communications that portray criminality, depravity or lack of virtue in, or that incite violence, hatred, abuse or hostility toward, a person or group of persons by reason of or by reference to religious, racial, ethnic, national or regional affiliation are condemned."

# Illinois Constitution Article 1 Section 3: Religious Freedom

"The free exercise and enjoyment of religious profession and worship, without discrimination, shall forever be guaranteed, and no person shall be denied any civil or political right, privilege or capacity, on account of his religious opinions; but the liberty of conscience hereby secured shall not be construed to dispense with oaths or affirmations, excuse acts of licentiousness, or justify practices inconsistent with the peace or safety of the State. No person shall be required to attend or support any ministry or place of worship against his consent, nor shall any preference be given by law to any religious denomination or mode of worship."

**Please Notice:** Licentious behavior must not occur on the part of any person, agent or trust indentured servant. Therefore, avoiding licentious behavior would apply to any person, as an agent of the State of Illinois, who attempts to inflict an unlawful mandate on one of the People of the State of Illinois. Licentious behavior may be construed to mean acting without regard to law, ethics, or the rights of others;

## Illinois Constitution Article 1 Section 12: Right to Remedy and Justice

"Every person shall find a certain remedy in the laws for all injuries and wrongs which he receives to his person, privacy, property or reputation. He shall obtain justice by law, freely, completely, and promptly."

## Illinois Constitution Article 1 Section 23: Fundamental Principles

"A frequent recurrence to the fundamental principles of civil government is necessary to preserve the blessings of liberty. These blessings cannot endure unless the people recognize their corresponding individual obligations and responsibilities."

**Please Notice:** The right to exercise of religion is not limited to a certain time or place; but, is not only allowed, but protected, under all situations and circumstances and is to not be limited by any agency, trust indentured, elected official, or any other influence outside that of the individual;

**Please Notice:** Equal protection of law describes equal rights and privileges of law and therefore makes null and void any attempt to cause harm personally or financially to any one of the People in the state of Illinois. As the unlawful mandate, disallowing basic rights of the People, violates equal protection of laws, it must be immediately withdrawn and removed from any possibility of further harm to "We, the People;

**Please Further Notice:** The present "mandate" disallowing the People's inalienable and indefeasible rights to choose religious accommodation, based on strong religious convictions, is without merit and forms an illegal precedent for further overreach of governmental agencies in the future. It is an attempt to disenfranchise and diminish the status of "We, the People" to accomplish an arbitrary end of questionable merit. It is licentious in nature, acting without regard to law, ethics, or the rights of others.

I, acting on my Constitutional authority as the progeny of the creators and sustainers of the Constitution of the United States and the Constitution of the State of Illinois, do hereby require immediate relief from all such mandates and restrictions upon my liberty interests, including my children, and rights as one of "We, the People." No agency, elected trustee, or entity has or will have authority to direct the private decisions of the People.

My desire is to settle this matter in a calm and harmonious atmosphere of mutual respect. However, no further infringement on the People's rights will be tolerated. Please see to it that this matter is resolved properly and expeditiously. If you desire to respond to this notice, your response must be in the form of an affidavit, answering point by point the statements contained herein; and, it must be received no more than 5 days from the receipt of this notice. I come to you peaceably trusting your actions will also reflect good intentions and honorable behavior.
