Notice of Religious Freedom Regarding Mandates

Notice to Agent is Notice to Principal and Notice to Principal is Notice to Agent

I, _____, one of the People (as seen in the Missouri State Declaration of Rights and all 50 state constitutions) am giving you this notice that you and your agents may provide due care and carefully act to cease and desist from all interference with the rights of the People;

The Missouri Constitution Preamble states: “We, the people of Missouri, with profound reverence for the Supreme ruler of the Universe, and grateful for His goodness, do establish this constitution for the better government of the state.”

Please Take Notice: From the inception of the State of Missouri, Almighty God was acknowledged. In addition, from the inception of US Constitution, Amendment I, religious freedom was guaranteed;

Please Take Further Notice: The People’s right to practice religion, in its various forms, was established from that point to the present.

Missouri Constitution Article 1 Section 1: Source of Political Power—Origin, Basis and Aim of Government

That all political power is vested in and derived from the people; that all government of right originates from the people, **is founded upon their will only, and is instituted solely for the good of the whole.** [Emphasis by highlight]

Please Take Notice: In relation to the rights of one of the People of the State of Missouri, or any other of the 50 states, **inalienable** rights are rights which are not capable of being surrendered or transferred without the consent of the one possessing such rights. Black’s Law 5th Ed.;

Missouri Constitution Article 1 Section 2: Promotion of General Welfare—Natural rights of Persons- Equality under the Law—Purpose of Government

That all constitutional government is intended to **promote the general welfare** of the people; that all persons have a **natural right to life, liberty, the pursuit of happiness and the enjoyment of the gains of their own industry; that all persons are created equal and are entitled to equal rights and opportunity under the law;** that to give security to these things is the principal office of government, and that when government does not confer this security, it fails in its chief design. [Emphasis by highlight]

United States Constitution Bill of Rights Amendment I

Congress shall make **no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech,** or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances. [Emphasis by highlight]

Please Take Further Notice: Within the Missouri State Constitution, there are no provisions for removal of this very first noted basic right of “We, the People;”

Missouri Constitution Article 1 Section 8: Freedom of Speech—...

That no law shall be passed impairing the freedom of speech, no matter by what means communicated: that **every person shall be free to say, write or publish, or otherwise communicate whatever he will on any subject, being responsible for all abuses of that liberty;** [Emphasis by highlight]

Take Notice: No state or federal “mandate,” may ever violate the inalienable rights of one of We, the People, enumerated in the Missouri Constitution. Concerning my choice, giving informed consent for a vaccination or not choosing to be vaccinated, wearing a mask or not wearing a mask, no other entity, outside of myself, may make that choice for me;

Missouri State Constitution Article 1 Section 9 – Rights of Peaceable Assembly and Petition

That the people have the right peaceably to assemble for their common good, and to apply to those invested with the powers of government for redress of grievances by petition or remonstrance

Missouri State Constitution Article 1 Section 10 – Due Process of Law

That **no person shall be deprived of life, liberty or property without due process of law.** [Emphasis by highlight]

Take Notice: No state or federal “mandate,” may ever violate the inalienable rights of one of We, the People, enumerated in the Missouri Constitution. Concerning my choice, giving informed consent for a vaccination or not to choose to be vaccinated, wearing a mask or not wearing a mask, no other entity, outside of myself, may make that choice for me;

Take Further Notice: Definition of Discrimination, Black’s Law 5th Ed.

In constitutional law, the effect of a statute or established practice which confers particular privileges on a class arbitrarily selected from a large number of persons, all of whom stand in the same relation to the privilege granted and between whom and those not favored no reasonable distinction may be found. Unfair treatment or denial of normal privileges to persons because of their race, age, nationality, or religion. A failure to treat all persons equally where no reasonable distinction can be found between those favored and those not favored.

Please further notice that: "Title VII of the Civil Rights Act of 1964 Definitions, SEC. 2000e. [Section 701] For the purposes of this subchapter- (j) The term "religion" includes all aspects of religious observance and practice, as well as belief,..."

Please Take Notice: In compliance with constitutional authority, you as a corporation created in this state, must follow the US and Missouri Constitutions and accept the **exercise of Religious Freedom without discrimination**. This includes my right to choose not to be vaccinated, carry a vaccine passport, or wear any sort of face covering;

Missouri State Constitution Article 1 Section 5: Religious Freedom—Liberty of Conscience and Belief—Limitation

That all men and women have a natural and inalienable right to worship Almighty God **according to the dictates of their own consciences; that no human authority can control or interfere with the rights of conscience; that no person shall, on account of his or her religious persuasion or belief, be rendered ineligible to any public office or trust or profit in this state, be disqualified from testifying or serving as a juror, or be molested in his or her person or estate;** that to secure a citizen's right to acknowledge Almighty God according to the dictates of his or her own conscience, neither the state nor any of its political subdivisions shall establish any official religion, nor shall a citizen's right to pray or express his or her religious beliefs be infringed; **that the state shall not coerce any person to participate in any prayer or other religious activity,** but shall ensure that any person shall have the right to pray individually or corporately in a private or public setting so long as such prayer does not result in disturbance of the peace or disruption of a public meeting or assembly; that citizens as well as elected officials and employees of the state of Missouri and its political subdivisions shall have the right to pray on government premises and public property so long as such prayers abide within the same parameters placed upon any other free speech under similar circumstances; that the General Assembly and the governing bodies of political subdivisions may extend to ministers, clergypersons, and other individuals the privilege to offer invocations or other prayers at meetings or sessions of the General Assembly or governing bodies; **that students may express their beliefs about religion in written and oral assignments free from discrimination based on the religious content of their work; that no student shall be compelled to perform or participate in academic assignments or educational presentations that violate his or her religious beliefs;** that the state shall ensure public school students their right to free exercise of religious expression without interference, as long as such prayer or other expression is private and voluntary, whether individually or corporately, and in a manner that is not disruptive and as long as such prayers or expressions abide within the same parameters placed upon any other free speech under similar circumstances; and, **to emphasize the right to free exercise of religious expression, that all free public schools receiving state appropriations shall display, in a conspicuous and legible manner, the text of the Bill of Rights of the Constitution of the United States;** but this section shall not be construed to expand the rights of prisoners in state or local custody beyond those afforded by the laws of the United States, excuse acts of licentiousness, nor to justify practices inconsistent with the good order, peace or safety of the state, or with the rights of others. [Emphasis by highlight]

Please notice that licentious behavior must not occur on the part of any person, agent or trust indentured servant. Therefore, avoiding licentious behavior would apply to any person, as an agent of the State of Missouri, who attempts to inflict an unlawful mandate on one of the People of the State of Missouri. Licentious behavior may be construed to mean acting without regard to law, ethics, or the rights of others;

United States Constitution Bill of Rights Amendment IX

The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.

Please notice that the right to exercise of religion is not limited to a certain time or place; but, is not only allowed, but protected, under all situations and circumstances and is to not be limited by any agency, trust indentured, elected official, or any other influence outside that of the individual;

Please notice that equal protection of law describes equal rights and privileges of law and therefore makes null and void any attempt to cause harm personally or financially to any one of the People in the state of Missouri. As the unlawful mandate, disallowing basic rights of the People, violates equal protection of laws, it must be immediately withdrawn and removed from any possibility of further harm to "We, the People";

Please further notice that the present "mandate" disallowing the People's inalienable and inalienable rights to choose religious accommodation, based on strong religious convictions, is without merit and forms an unlawful precedent for further overreach of governmental agencies in the future. It is an attempt to disenfranchise and diminish the status of "We, the People" to accomplish an arbitrary end of questionable merit. It is licentious in nature, acting without regard to law, ethics, or the rights of others;

I, acting on my Constitutional authority as the progeny of the creators and sustainers of the Constitution of the United States, the Constitution of the State of Missouri, **do hereby require immediate relief** from all such mandates and restrictions upon my liberty interests and rights as one of "We, the People." No agency, elected trustee, or entity has or will have authority to direct the private decisions of the People;

My desire is to settle this matter in a calm and harmonious atmosphere of mutual respect. However, no further infringement on the People's rights will be tolerated. Please see to it that this matter is resolved properly and expeditiously. If you desire to respond to this notice, your response must be in the form of an affidavit, on penalty of perjury, answering point by point the statements contained herein; and, it must be received no more than 5 days from the receipt of this notice.

I come to you peaceably trusting your actions will also reflect good intentions and honorable behavior.
