Notice to UAW and State Legislature of the Rights of the People

I, _____, one of the People as seen in Michigan Constitution (Article 1 Section 1), present this notice that you and your agents may provide due care;

Michigan Constitution Article 1 Section 1: Political Power

All political power is inherent in the people. Government is instituted for their equal benefit, security and protection. (Highlight added for Emphasis)

Please take notice that the people of the State of Michigan have all political power and have elected all government officials for the purpose of protecting their rights. The people have a right to make their own decisions based on their religious and other beliefs;

Please take further notice that I hold religious beliefs that do not allow me to take vaccinations, consume things with blood or aborted babies, therefore it is against my will as one of the people and conscience to take the Covid 19 Vaccine (please see Constitutional Authority below):

Michigan Constitution Article 2 Section 2: Equal Protection; Discrimination

No person shall be denied the equal protection of the laws; nor shall any person be denied the enjoyment of his civil or political rights or be discriminated against in the exercise thereof because of religion, race, color or national origin. The legislature shall implement this section by appropriate legislation. (Emphasis by Highlight Added)

Please take further notice that the People, having all power, have the right to instruct the Legislature and the Legislature doesn't have authority to limit the People's freedom, nor can they make laws or can the executive branch make rules that would abrogate my freedom to choose what i will do for my own personal healthcare or treatments (please see the Constitutional Authority below);

Michigan Constitution Section 3: Assembly, Consultation, Instruction, Petition

The people have the right peaceably to assemble, to consult for the common good, to instruct their representatives and to petition the government for redress of grievances.

Please take further notice that the People have never given authority to their public servants to block instruction of the people and I as one of the people wish to put all on notice that I am declaring my right to handle my own private health, and no government

official, federal or state, may attack my ability to work by interfering with rights based on title 42 programs where wealth is made for administering the same (please see the below Authority):

Miranda v. Arizona, 384 U.S. 436 (1966)

Where rights secured by the Constitution are involved, there can be no rulemaking or legislation which would abrogate them.

Please take further notice that No Legislature in any Republic has ever been left power to write statute abrogating my rights, furthermore, no executive branch officer has the power to mandate or order their to be rules that removes my rights that all public officers swore to protect in the State and Federal Constitution;

**Michigan Constitution Section 17:
Self-Incrimination; Due Process of Law; Fair Treatment at Investigations**

No person shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty or property, without due process of law. The right of all individuals, firms, corporations and voluntary associations to fair and just treatment in the course of legislative and executive investigations and hearings shall not be infringed.

Please take further notice that even if there were to be some type of case to deprive a right of life, liberty or property, it could not be done in legislative tribunals, nor could it be done in executive processes which are not judicial. Furthermore, title 42 is non-positive law and administrative and does not bind any of the People of America as all public officials have already sworn to uphold. It is hereby my will, order, and instruction, that all Public Officers take notice of my declared rights, and refrain from trying to use any mandate, recommendations, or other tactics that would interfere with my right to make my own health decisions. Any failure to observe my rights means that you agree to pay \$20,000,000 for each encroachment upon my rights or interference with those whom I hold a contract to work with. This notice is sent in peace and in the love of Christ.
