**Please take Notice** We, the People, of North Carolina have inalienable rights. As the mother of Jamari Lavelle Miller-Ingram, I, the Affiant, wish to inform you that you are in violation of the North Carolina Constitution, which allows religious liberty for all the People. This religious liberty extends to what each one of the People may choose to put into their bodies- a vaccination;

## North Carolina State Constitution, Article I Section 13. Religious Liberty.

All persons have a natural and inalienable right to worship Almighty God according to the dictates of their own consciences, and no human authority shall, in any case whatever, control or interfere with the rights of conscience. [Emphasis by Highlight Added]

**Please take Notice** that We the People are the creators of all government in our Nation, both State and Federal. Government is only instituted for the protection, security, and benefit of the People, and not to usurp the rights of the People.

North Carolina Constitution Article I Section 1. The equality and rights of persons. We hold it to be self-evident that all persons are created equal; that they are endowed by their Creator with certain inalienable rights; that among these are life, liberty, the enjoyment of the fruits of their own labor, and the pursuit of happiness. [Emphasis by Highlight Added]

**Please take Notice**: The People's, are being impinged by blanket mandates regarding vaccination status. All the People may choose to receive or not receive the vaccination. It is a personal choice over which no agency has any authority. In addition, no agency may single out a particular group of the People for discriminatory practices, based on a category- not vaccinated;

## North Carolina Constitution Article I Section 12. Right of assembly and petition.

The people have a right to assemble together to consult for their common good, to instruct their representatives, and to apply to the General Assembly for redress of grievances; but secret political societies are dangerous to the liberties of a free people and shall not be tolerated.

**Please take notice that,** the people have constitutional rights to assemble together without limitations from government agencies enforcing discriminatory mandates;

## North Carolina Constitution Article I Section 3. Internal government of the State.

The people of this State have the inherent, sole, and exclusive right of regulating the internal government and police thereof, and of altering or abolishing their Constitution and form of government whenever it may be necessary to their safety and happiness; but every such right shall be exercised in pursuance of law and consistently with the Constitution of the United States.

**Please take notice that** as one of the People, it is my wish for you to take this Notice as truth unless you have constitutional authority to deny the right of association between mother, father, and our child. If you should fail to allow access, you agree that you are doing it with malice, intent,

Any man or woman who denies these claims are true must rebut them under penalty of perjury in the form of a sworn affidavit. Any man or woman who decides to suppress this affidavit agrees to pay \$50,000 and any disputes by any public officials or private actors who are bound by contract to the North Carolina Constitution agrees to have these matters heard before an Arbitrator of my choice and at your expense. Any man or woman denying these claims are true must rebut these claims point by point within (5) days (120 hrs). Failure to respond means that by acquiescence you agree that all claims are true.
